In the Ambassador's residence, the Management Board of AmCham had the opportunity to discuss the most important issues for American investors in Poland and U.S.-Poland relations.



Meeting with U.S. Ambassador Mark Brzezinski and defense sector companies

In March, Ambassador Brzezinski met with U.S. defense industry companies to learn more about their operations in Poland and the challenges their businesses face in the local market. The meeting was also an opportunity for these companies to share an overview of their cooperation with the Polish Ministry of Defense and the Polish Armaments Group (PGZ S.A.), and to discuss Poland's development potential within the defense sector.

Our guest's experience in the Departments of State and Defense and as Ambassador to Poland offered an excellent opportunity to discuss the more critical issues and challenges facing Poland and our region in these difficult times. Breakfast Meeting with Ted Hart, CEO of CAF America

Along with the founders of CAU (Corporate Aid for Ukraine), AmCham had the pleasure of welcoming Ted Hart, the CEO of CAF America, for a breakfast meeting this November. CAF America is one of the leading donor-advised charitable funds in the U.S. The meeting participants, which included around 50 Polish and Ukrainian charitable organizations, had the opportunity to explore and discuss the realities of helping Ukraine and Ukrainian refugees in Poland. With winter just around the corner and Ukrainian power generation at risk, donating to organizations supporting Ukraine became more important than ever.





AmCham CEO Forum with Ms. Charlotte Hogg, CEO of Visa Europe

In late November Charlotte Hogg, CEO of Visa Europe visited Poland. Along with Visa, AmCham had the pleasure of organizing a CEO Forum featuring a debate on "The power of female entrepreneurship: How to promote diversity and inclusiveness in the economy and finance?". The debate aimed to present the available solutions and identify possible areas of cooperation between public and private entities to increase inclusiveness and sustainable development in the financial market. The discussion was moderated by Tony Housh, AmCham Chairman, and included the following panelists: Elżbieta Czetwertyńska, Citi Country Officer for Poland; Joanna Erdman, CEO of Fundacja Polska Bezgotówkowa (Cashless Poland Foundation); Joanna Seklecka, CEO of eService; and Katarzyna Szwarc, Plenipotentiary for Capital Market Development Strategy, Ministry of Finance.



Meeting with Magdalena Rzeczkowska, Minister of Finance

Representatives of key AmCham member companies met with Magdalena Rzeczkowska, the Minister of Finance, and her team. During the meeting, we appealed to the Minister for the stability of the law, which is a fundamental thing for businesses. We also discussed the top burning issues facing the contemporary business community.

The Polish Deal and its amendments planned this year, together with the consequences of rapid tax reforms for companies and their employees, changes to CIT, the Global Minimum Tax, cybersecurity, the relation between Polish and European laws in the context of sanctions imposed on Russia over the Ukraine invasion, the system of E-invoices, challenges for the banking sector, and the other upcoming plans of the Ministry.





U.S. Congressional Staff Member Meeting

AmCham hosted U.S. House and Senate representatives. The Congressional Staff Members were visiting Poland with a program focused on U.S.-Polish cooperation, and its most important political, military, and economic issues. Thanks to the Polish Embassy in Washington, D.C., we had an excellent opportunity to discuss the most critical issues related to running a business in Poland, further development of Polish-U.S. relations, and the challenges facing foreign investors.



Meeting with Waldemar Buda, Minister of Development and Technology

AmCham met with Waldemar Buda, the Minister of Development and Technology, and his team. During the meeting, we discussed the most important topics for the U.S. investors in Poland: the National Recovery Plan, changes to Labor Law, potential energy shortage, quality of education, implementation of the DSM Directive, and many burning issues for particular business sectors.





Energy Roundtable & Energy Day Conference

On April 6, 2022, AmCham and the UN Global Compact Network Poland organized an Energy Roundtable. At the meeting, the disputants discussed an action plan for an energy transformation in Poland and drafted a path of critical needs in the following months and years. Stopping climate change, reducing Poland's dependency on Russian fossil fuels, and maintaining Poland as an attractive place to invest were some of the common aims clearly expressed by our distinguished guests: Mark Brzezinski, U.S. Ambassador to Poland, Katarzyna Zajdel-Kurowska, Executive Director at the World Bank Group, and government representatives: Maciej Małecki, Secretary of State at the Ministry of State Assets; Mariusz Golecki, Undersecretary of State at the Ministry of Economic Development and Technology; Piotr Naimski, Government Plenipotentiary for Strategic Energy Infrastructure and representatives of AmCham and UNGC member companies.

Six months later, on October 6, 2022 UN Global Compact Network Poland came back with the full-day conference — Energy Day, that gathered nearly 200 guests. Our guests included Ambassador Brzezinski, Tony Housh, AmCham and Kamil Wyszkowski, UNGC, opened the event. Bartłomiej Pawlak (PFR), and Grzegorz Slomkowski (PAIH), emphasized the importance of stability and predictability of business energy supplies in their opening speeches, which were then followed by panel discussions. Katarzyna Szwarc (Ministry of Finance), Andrzej Kaźmierski (Ministry of Economic Development and Technology), Tomasz Nowacki (Ministry of Climate and Environment), and Robert Rudich (U.S. Embassy Warsaw), took part in 3 consecutive panels to discuss the financial aspects of green transformation, ways to sustain the competitiveness of businesses operating in Poland in the era of an energy crisis, and finally upcoming nuclear revolution in the energy sector.

The AmCham Economic Research Unit (AmCham ERU) aims to deliver information describing the effects of U.S. capital on the Polish economy. It analyzes U.S.-owned businesses in Poland, and their impact on the country's economy and quantifies various aspects of Poland-U.S. economic relations.

This year the AmCham ERU has published its articles in Polish media: onet.pl, Warsaw Business Journal, Poland Weekly.

AmCham ERU promotes U.S. business in Poland and Poland-U.S. economic relations. We also provide numerous comments, interviews, and data for media and public administration. There was recent cooperation with Polish Press Agency, PolskiPrzemysł.pl, Kapitał Polski, Tok FM, as well as U.S. Embassy and local Polish administration.



AmCham Poland speaks for American companies operating in Poland on the issues of investment, trade, and competitiveness. We aim to ensure a growth-oriented business and investment climate in Poland. AmCham provides a platform for discussion and debate on the legal environment in Poland and takes an active part in the legislative process. AMERICAN a support program assisting Polish looking to expand to the United States. AmCham Poland's American Investor Desk (AID) is a support program assisting Polish companies

During 2022 AID, focused on strengthening the partnership with the Polish Investment and Trade Agency, U.S. Commercial Service, and economic development organizations in the United States. At the same time, AID was helping numerous Polish companies, representing various industries, to define directions and partnerships for their future business in the U.S.

After a series of "Select USA" events, planned for early March 2022, were canceled due to Russian aggression on Ukraine. AID, together with its partners, continued its education mission: explaining to Polish entrepreneurs the possible scenarios of entering the U.S. market, its potential, and possible opportunities.
